



Introduction

"No government, organization or person has the right to control the pace of our advancing human consciousness by holding back the truth - honesty directs us to a better place"

Colin Andrews-2009

I have been researching crop circles for more than 25 years. During this time I have interacted with British authorities on the subject at many different levels of government and Royalty. I've been reporting on these interactions during lectures, on tape and in books since 1989.

Recently, a new and disturbing development has occurred, where officials are rewriting history as to the level of government interest and involvement with the mystery. This is done through the release from the National Archives of select or altered Military of Defence (MoD) classified documents.

I first saw this in effect with an article written by Nick Pope, formerly head of the MoD-UFO project. In his article Nick Pope claims that there was not substantial official interest or investigation in the subject of crop circles by the MoD, Houses of Parliament, County police, or the Royalty.



In his article Nick Pope specifically claims that:

- The MoD did not have an in-depth or lasting interest in the subject and he debunks many of the claims I have made regarding my government level interactions. Pope sites the Hansard record from the Houses of Parliament as evidence that the Military have not worked with any civilian research group on the crop circles mystery. I have proof that this is patently untrue which I will provide in this article.
- Pope claims there was no involvement with County police and shows an official record from Hampshire and Wiltshire police chiefs stating that their officers were not carrying out any official investigations. This is misleading if not outright false and I will provide evidence to that effect.
- Pope goes on to say that "he had to deny" any interest of the Queen or other members of the Royal Family in the crop circles. I will provide personal letters I received from Her Majesty the Queen and Prince Philip which show Pope's statement to be false.
- Nick further says that the use of a government D-notice was never used to stifle media coverage of crop circle events specifically those at Operation Blackbird. A D-Notice is a government enforcement order to cease media transmissions of material considered to be a threat to national security. Well known television and radio presenter Dave Barrett's experience to the contrary is included in this article.



Introduction

Nick Pope's claims have been reinforced with the recent release of MoD National Archive records under an extension of the Freedom of Information Act. The media reported extensively on the records release and some articles can be seen in this document. I know that these records are incomplete and in some cases false and will present the evidence in this report.

I don't believe the timing of Nick Pope's article and the MoD records release are coincidence. I can think of only two explanations for the incomplete and wrong information in both. Perhaps high level inter-governmental sharing of information on the subject has been on a need-to-know basis and not only the public but Prime Minister Margaret Thatcher and Nick Pope were being misled. Or perhaps the government is trying to rewrite history and downplay their interest and involvement in the subjects of crop circles and UFOs using Nick Pope to open the door to this approach. I wrote to Nick on September 15, 2006 to dispute his version of these historical events as I knew them.

To change the record on government involvement in the mystery requires that the record on my own involvement with the government be changed as well. Fortunately I have proof of my claims. I can demonstrate interest and interaction with local authorities in Wiltshire and Hampshire counties, the MoD, Nick Pope at the UFO Project Department, members of Parliament and the Prime Minister Margaret Thatcher's cabinet, and the Royal Family.





Local Government In Hampshire & Wiltshire Counties, UK

I was employed in local government at Test Valley in Hampshire from 1974 to 1990. This proved to be a door opener into the Hampshire and Wiltshire Police authorities (and also into central government) who readily shared with me information they had collected on crop circles.

At the time, late 1980's and early 1990's, crop circles represented a completely new situation and were drawing massive numbers of people into the countryside. It would have been negligent if government per say, local and national, was not fully informed on the extent of the phenomenon.

I was actively investigating crop circles, was an electrical engineer, came from local government and was a credible affiliate. I worked with cooperative individuals at very high levels within the Hampshire and Wiltshire police aerial surveillance operations. The pictures in this document are all photographs given to me by these individuals in an official capacity.

Nick Pope has stated that any photo's taken from military helicopters were taken by interested individuals and not under

the directive of police headquarters. This is simply not true. The police in Hampshire provided me with a direct telephone number to the commanding officer of the flight control operation at Lee-On-Solent.

I was given this access because I was receiving daily reports of newly arrived circles from private aircraft and helicopter pilots, the public, farmers, and others. I passed selected reports to the flight control operations who then directed official aircraft to take immediate photographs for their use.

Our joint cooperation was reciprocated with my receipt of their aerial photographs. With this arrangement many times the authorities were present to record a crop circle formation before the public and in some cases even the farmers were aware the formation existed.

Occasionally I would be on site to witness the arrival of the aircraft I had requested, as can be seen in this photograph. This level of involvement is far above individual interest and demonstrated unprecedented co-operation with private research efforts, as the times dictated, contrary to Pope's assertion or the official statement in Parliament.





The Involvement Of The Military

"Throughout the late 1980's and early 1990's military aircraft over crop circles were commonplace and witnessed by all who visited the circles. Military aircraft were witnessed taking photographs and maneuvering over the formations regularly."

I received extraordinary cooperation from military airbases throughout South Central England in my research as did other researchers such as George Wingfield.

For example, Wingfield revealed that he was part of a series of photographic expeditions on aircrafts provided by the Army Air Corp at Middle Wallop airbase for the purpose of taking close-up aerial photographs of crop circles in the Andover and Marlborough areas of Hampshire and Wiltshire. A senior member of the House of Lords was on board during at least two of those over-flights.

I am aware that much of the skepticism about my personal claims has arisen due to the lack of cooperation given by the military to some other crop circle and UFO research organizations. I can only reiterate that my local government position may have given me a slightly credible position, however, I think the real reason was



reason was that it never occurred to me that they would not be helpful. Consequently I was respectful, cooperative, persistent and fully anticipating reciprocation. This is considerably different than the poorly masked hostility in many approaches to the military of this kind.

I find it ironical that in the 80's and 90's I was accused of being a government cohort due to the help I was given and now I am accused of making up government involvement! How the wheel turns. I am openly accused on various websites of carrying out CIA or Rockefeller instructions to down play the crop circle and UFO phenomena when the exact opposite is the truth. Many instances of military presence at the crop circles and assistance provided to me with evidence to support my claims.

The Summer of 1985

In the summer of 1985 Busty Taylor discovered and photographed a set of five circles near Longstock in Hampshire. By the time Taylor landed his aircraft and arrived at the site for ground analysis military aircraft were already overhead photographing the formation.

The farmer of the field believed the circles were formed by the activity of military helicopters as his fields were in close proximity to the Middle Wallop army airbase and low level helicopter activity occurred frequently.

The farmer lodged a complaint at the airbase which instigated an investigation led by Lieutenant Colonel Edgecombe. The official report was sent to the MoD. Nick Pope plays down this report as an action taken to placate the public.


However, after Lt. Col. Edgecombe's investigation I telephoned the airbase asking to speak with him. During the course of our conversation I was invited to visit the airbase for further discussion. My visit resulted in being given a copy of Edgecombe's official report and photographs of the site, the same reports that was also sent to the MoD and was dismissed by Pope.

I agreed not to publish the report at the time but am doing so now. I am releasing this to demonstrate that Pope neglects to mention several important aspects of this report. He fails to mention that the Colonel was on board the helicopter that investigated the circles and had with him the Aircraft Accident Investigations Officer who were both baffled by what they saw.

The report states that they could not find any tracks into or out of the field and one particularly inexplicable feature was a circle remote from the tractor tram lines which also had no tracks to it. They even question if it was caused by a UFO. The report ends by saying none of those present could offer a reasonable explanation for the circles but they were certainly not aircraft down wash.

I am not using this event as evidence that these crop circles were not man-made or that the military believed they were extraterrestrial in origin. I am simply demonstrating that there was interest in the subject at very high levels.





The Involvement of the Military

The Fall of 1987


In the first week of September 1987 I was in conversation with the flight control tower at the Boscombe Down top secret air establishment requesting information on any new formations reported by their pilots.

I was in the habit of regularly checking with the airbase for this type of information. At this time they informed me of a set of five circles seen from the end of the runway. The circles were in Amesbury near Stonehenge.

In pursuing this report I was permitted access to a meeting with the head of the photographic division where personnel thumbed through serialized negatives to show me crop circle photographs they had taken.

Several were extremely valuable to me as they added significant information to the details of our own site work. For example one photo was taken one hour prior to our own visit to the same site.

In their photo the swirl pattern in the circle was counter clockwise and the plants were laid flat. In our photo of the same circle the swirl was clockwise and the plants were tufted. A change of this sort had never been witnessed before. I left Boscombe Down gifted with large prints of photographs that were of interest to me.





Operation Blackbird

The military were involved with several high profile surveillance efforts, the most prominent being Operation Blackbird in the summer of 1990. This was a three week long high-tech surveillance stake-out overlooking fields near Bratton and Westbury in Wiltshire. This was determined to be the most likely site for recording a crop circle being formed. There was a high degree of media coverage of this operation:

- The Royal Army Ordnance Corp, at the Deepcut Army base provided the best military night vision cameras available to be used during Blackbird. The equipment cost thousands of pounds.
- The Army also provided personnel with technical expertise to help with the surveillance camera operations which can be seen in the pictures on the same link as above. The two officers provided were deployed from TRG Wing, HQ CO4, and TRG BN at Depot RAOC, in Blackdown Barracks, Deepcut, Camberley, Surrey.
- Unbeknown to the public there was another covert operation being conducted by the army at Silbury Hill just 19 miles away from Blackbird. This site was deemed the second most likely spot to record a crop circle being formed. The Army procured footage of their operations which I asked for and was given at the end of our coordinated efforts. The CPR Archive contains the copies of this Army footage.



While we maintained a public presence at Blackbird with many media cameras present, Army personnel were using special image intensifier cameras along with mobile recording shoulder packs at the second covert site. Night-vision recordings filmed a team of hoaxers as they walked into the fields within touching distance of army personnel hidden in the crops around them. The Army also filmed a bright pulsing object over the field to the south of them during the covert surveillance operation.

Squaring up the Circles

In October 1989 the BBC aired a program titled *Squaring up the Circles*. The program focused on finding the source of the crop circles. Crop circles had appeared on MoD land in Heytesbury near Warminster over a period of years. During the production of *Squaring up the Circles*, the BBC went to this piece of property and enlisted the help of the military to uncover the source of the circles. The Army sent a team to make a crop formation which was then compared to the "real phenomenon".

The formation they made had none of the classic features; it was messy, poorly constructed, asymmetrical, had broken and damaged plants, and entry and exit points were clearly visible. Next the military used a gazelle helicopter to hover at very low levels over the wheat field to observe crop damage caused by the down wash. Again, the classic features were not recreated. CPR Archives hold a copy of the BBC-2 program *Squaring up the Circles*, presented by Caroline Hall, aired October 27, 1989.






The Army Helicopters

The Army photographed a second group of circles which were taken by the same helicopter at Westbury/Bratton on the August 4, 1987. The Army photograph shows the circle bottom/right, swirled counter clockwise.

When Pat Delgado, Busty Taylor, Dr. Terence Meaden and I, entered the field to do research a few hours later, the circle was found to be much more complex than seen in this Army photograph and was then found to be swirled clockwise around raised tufts. Each circle was also enlarged by approximately two feet.

The Army helicopter took the photograph to the right. The bottom/right circle was found to have changed its ground detail just a few hours after the Army photograph was taken. There is a

The Involvement of the UK Ministry of Defence (MoD)

Many people may not be aware that the MoD has a departmental position that specifically responds to and investigates UFO's and related phenomena. My initial inquiries at the Ministry of Defence were about UFO sightings that occur in association with crop circles.

I was specifically interested to know more about UFO reports received at Boscombe Down air base as I was interacting with officials at the airbase in regards to the ground phenomenon. I also wanted to look at the crop circle-associated UFO files that had been processed and stored in the National Archives in London.

Shortly after I began my research I met with Ralph Noyes who formerly was head of the UFO project at the MoD. Ralph Noyes was promoted to Under Secretary of State, a high level position in the British government. We had several meetings to discuss reports I had submitted to the government, one of which



When he fully retired from government he was fascinated with the crop circle mystery and the UFOs seen near them and became a founding member and director of the Center for Crop Circle Studies (CCCS).

Noyes position in the UFO project at the MoD was some years later taken by Nick Pope. I had my first meeting with Pope in 1993 and corresponded with him also around 15 times during his time in this position. On July 27, 1993 I attended a meeting I was instrumental in setting up between Nick Pope and professionals from the U.S. who were interested in sharing information to better understand the UFO subject. Present at the meeting in London were myself, Nick Pope, Dr Steven Greer and Dr. C.B. Scott Jones, former US Naval Intelligence and advisor to late United States Senator Claiborne Pell, head of the Senate Foreign Relations Committee.

While Nick Pope towed the official line, over time it became obvious that what he believed personally was different. While he was spokesperson for the MoD on one hand, his personal view seemed to be that UFOs not only exist but are a real concern to national security. He also stated he believed they existed in large numbers.

Just before Pope retired from the MoD, I provided an introduction for him to speak at his first public lecture on UFO's at the New Hampshire MUFON conference in 1995 organized by Pete Geremia. At that conference Nick stated that as many as 5% of UFO reports investigated by the full apparatus of the MoD were thought to be totally unexplained – he went on to say they were probably extraterrestrial.








The Involvement of the UK Ministry of Defence (MoD)

In Nicks' article he decries involvement of the MoD with crop circles. However, Nick himself, while working at Sect 2A at MoD, offered to mobilize aircraft into the Salisbury Plain 'military zone' at my request for UFO or crop circle reports should he feel the request was warranted. I never asked for such assistance from him but did use local assistance as detailed above.

Despite this extensive history Nick Pope underplays any lasting involvement or interest of the MoD in crop circles. I find this extraordinary!

Who Briefed The Prime Minister?

"I discussed my findings in depth and stated my belief that there was more than a hint of 'intelligence' at work in the fields, and I did not mean human."

Much controversy has been generated by my claim to have provided reports to the Margaret Thatcher cabinet. During the late 1980's I was asked by a retired Army Captain to provide data to Dr. Fisk the Chief Scientific Advisor to the Margaret Thatcher government to be the basis of reports sent to the Prime Minister and the Secretary of State for the Environment.

These reports were to help the government assess the scope and significance of the crop circle phenomenon. The reports and my involvement in creating them have been acknowledged in numerous official letters.

The Captain, whose name I am with-holding, visited my home in Andover, Hampshire and asked if I would provide specific details on my research conducted over the previous six years. At the time the general consensus was that crop circles were made by an unknown natural process, a conclusion I felt was limited. I discussed my findings in depth and stated my belief that there was more than a hint of 'intelligence' at work in the fields, and I did not mean human. We also discussed the unusual orbs that had been seen by multiple witnesses.


Who Briefed The Prime Minister?

I saw an orb for the first time as I waited for Dr. Terence Meaden to arrive at a circle site near Winchester, in 1986.

I provided my findings and additional data to the Captain. His staff prepared the subsequent reports which were sent to Nicholas Ridley, M.P., Secretary of State for Environment in Prime Minister Margaret Thatcher's cabinet. These were routed via Lord Tony Dulverton. Copies were also forwarded to the Ministry of Defense, the Queen, the Governments Science advisor Dr. Fisk and Richard Ryder at the Ministry of Agriculture Fisheries and Food (MAFF).

According to the recently released records from the MoD, once in the late 1980's and once in the early 1990's, the public and the Prime Minister were told by the Home Secretary in the Houses of Parliament that the police forces of Hampshire and Wiltshire and the MoD had no interest in the crop circles and were not at that time filming or investigating them. This denial was repeated in Parliament and recorded in Hansard.


As I stated in the beginning of this report, the ground was prepared for today's UFO/crop circle research community to accept this deception with the pre-publication of Nick Pope's article alleging the same. Information and evidence I have presented here demonstrate that despite these claims to the contrary the military and police were deeply interested and engaged in the phenomenon.

How Were Members of Parliament Involved?

During the time I was providing data for official reports I also increased attempts to have questions raised in Parliament. Other UFO researchers were doing the same such as Jenny Randles and Paul Fuller as mentioned in Nick Pope's article. Months earlier I sent our first book *Circular Evidence* to Sir David Mitchell, M.P. (Member of Parliament), which he acknowledged.

Eventually I was able to arrange a meeting with Sir David Mitchell and took him into the fields to view a formation. I showed him the features we were investigating and explained the difficulty in identifying them as man-made formations. I also demonstrated why they did not appear to be randomly positioned as expected if they were created by a natural process such as whirlwinds.

After a second meeting with Sir David Mitchell he became convinced the government should be involved in researching the details and photographic evidence he had seen. He promised to discuss the phenomenon with other ministers.





he was instrumental in ensuring that my reports reached the Deputy Prime Minister, Sir Geoffrey Howe. His efforts also led to a meeting with Minister of State at the Department of the Environment, David Trippier. Discussions between Mitchell, Trippier and his Chief Scientific Advisor led to the decision to approach the Natural Environmental Research Council to request an official research interest.

I was touched and honored to receive a glowing reference back from Sir David and later letters from him and Dr. Fisk to confirm progress in the government's willingness to proceed down the road of funding for official research into the crop circles. This avenue was closed down due to the fact that there were no PhD scientists who had studied the phenomenon and written a peer reviewed article at that time.

A later article written by William Levengood and published in the peer review journal *Nature* was not sufficient to reopen this door; however, for Nick Pope to say there was no interest or intent is misleading in the extreme.

While time has moved on and the hoaxing has continued to grow, there are still compelling facets to this phenomenon that I believe constitutes new grounds to re-open this avenue for investigation.

What Did The Royal Family Want To Know?

In fact the interest of the Queen in the subject was evident in the late 1989 when she put *Circular Evidence*, on the Queen's Summer Reading list.


Pat Delgado and I also received an official request for the *Circles Phenomenon Research Newsletter* to be delivered regularly to the Queen and the Duke of Edinburgh at Buckingham Palace. On October 31st, 1989 I received a letter from the Duke of Edinburgh thanking me for keeping him informed, and requesting to be kept up to date with the research into the crop circles.

Nick Pope states that he "had to deny allegations that the Queen and Margaret Thatcher had expressed interest in the phenomenon." I wonder how Pope explains this personal letter I received from Her Majesty the Queen which completely puts to rest his public denial that she and the Duke had any interest in the phenomenon. In this letter the Queen's private secretary conveys the Queen's personal long-time interest in the crop circle mystery.

In 1991 the same retired Captain who requested my data for the Prime Minister relayed a request to me to show Prince Charles around one of the formations near his property. Prince Charles wanted me to explain the features we were convinced at the time were of a genuine phenomenon. Although a plan was set for such a meeting to take place an unfortunate leak to the media scuttled our meeting.

To this day I do not know how secret plans for me to show Prince Charles around the crop circles was intercepted by *The Daily Star*, a British national newspaper.

Our plans were reported in the June 28, 1991 publication resulting in their cancellation. Prince Charles had crop circles on one of his estates as did other members of Royalty and his interest was high. While Prince Charles could not enjoy first-hand exposure to the circles, Jonathan Deane Montigue, son of the 3rd Baron Montigue of Beaulieu accompanied me around the circles for two days. Jonathan's home is Beaulieu Abbey, which was dissolved by King Henry the VIII.

A British Government D-Notice was/is a military directive to stop publications and radio or television transmissions on grounds of national security concerns. Several years after Operation Blackbird, I learned from a well known radio and television presenter, Dave Barrett, that such a notice had indeed been issued during the live transmissions from Operation Blackbird.

According to Nick Pope, the D-Notice is no longer in use today, but I provide proof that this is not so. At the time Dave Barrett was with GWR radio based in Swindon, Wiltshire. Dave Barrett was back in the studio as the GWR outside broadcast vehicle and attempted to transmit' live' from Blackbird when he received the D-Notice to stop.

The D-Notice was received as four military training aircraft were flying at low level directly over the heads of Pat Delgado and I as we were entering the center of the newly discovered crop circle which had occurred on the edge of the surveillance parameters.

In the center of the circle we found an advanced astrology board and concluded that somehow we had been tricked. Many people insist there was more going on here than we knew, including the soldiers who attended the site. When I met Dave Barrett several years later at a conference in Bristol, England he said: "I have for so long wanted to ask you what really went on there that day for the government to take such drastic action."

I have no idea what instigated military interference with the media news. I suspect that the second covert operation occurring simultaneously with Blackbird may yet reveal important information regarding this. The story of what I know regarding the second covert operation at Silbury Hill has never been told. The purpose here is to dispel Nick Pope's allegation that no such D-Notice was given.

Nick Pope states: "I was quizzed by several crop circle researchers who asked for details of what the MoD knew about the phenomenon. Some demanded that we take action to investigate matters, while others clearly thought we knew all about it, and were covering up. New theories and allegations abounded and I was often on the defensive. I had to refute the bizarre idea that the formations were caused by the testing of space-based laser or directed-energy weapons, and dispel suggestions that media coverage of the issue had been stifled by the use of D-Notices.

I recently contacted Dave Barrett via email to confirm that GWR radio did in fact receive the D-Notice. He recalled the event and replied that although his radio station sent a radio vehicle to the site "they were prevented from seeing the circle and the D-Notice stopped us reporting it."

My research into crop circles has sent me around the world and into the company of former high level officials in the US and Russian military and also the NASA AMES research facility, among others.

My discussions leave me to believe that governments from many countries have been concerned with the question of both UFO's and crop circles, regardless of what the public has been told. The following events which support my position took place during the past twenty-five years.

In 1991 I was part of a press conference in San Francisco with Russian Cosmonaut and pilot, Dr. Colonel Marina Popovich. With authority from the Russian government Dr. Popovich released photographs taken during Russian space missions of UFO's near Phobos, the moon of Mars.

I was asked to make a presentation in 1992 in Washington, DC, which was attended by President Bill Clinton's chief scientific advisor, Dr. Arlan Andrews from the office of Science and Technology Policy. Our discussions after my presentation were amongst the most enlightening in regards to the UFO that I have ever had. Its obvious to me that it's not the individuals that are holding back the day of open co-operation and ultimate advancement of our knowledge, it's a piece of paper on which is written a single word 'Policy'. An agreement made years ago by scared people who took it on themselves to protect themselves as well as the rest of us from the step beyond to an inhabited universe where ultimately we will go.

In 1993 a subgroup at the United Nations, *The Society for Enlightenment and Transformation* (S.E.A.T.), headed by Mohammad Rammadan organized a symposium on UFO and related subjects. In addition to myself Dr. Rauni Luukanen-Kilde, a former chief medical doctor from Iceland, and Dr. John Schuessler, Deputy Director of Mutual UFO Network (MUFON) an aerospace engineer with the space station Freedom, were the speakers. This symposium made it clear that there is International governmental interest in the phenomenon as witnessed by the current number of governments who are releasing their top secret UFO files.

In 1997, I spent ten days at an International Science congress in Hakui, Japan. Also present was Dr. Richard Haines from A.M.E.S. research facility. We spent much time discussing theoretical models for the construction of crop circles.



In 1998, I was involved in several meetings with Retired Colonel Philip Corso who was part of President Eisenhower's National Security Council from 1953-1957. Corso told me that in the course of his professional career he was shown pictures and reports of crop circles and witnessed them being passed to the National Security Agency (NSA) for study. This was confusing to me because I didn't know crop circles were under investigation as early as the 1950's or perhaps he maintained a government presence after the Eisenhower years. This was never explained.

Corso went on to reveal that Prof. Allen Hynek was involved in analyzing the reports, later confirmed to me by an NSA operative. Prof. Hynek was an astronomer and ufologist who acted as scientific adviser to UFO studies undertaken by the U.S. Air Force in three consecutive named projects: Project Sign (1947-1949), Project Grudge (1949-1952), and Project Blue Book (1952-1969). Colonel Corso also told me that the NSA held the view that the crop circles were a form of communication.

I later received two diagrams from an NSA operative of complex crop circle designs found in Michigan. I could easily see why the NSA would view them as communication.

In 1997 through 1999 I received funds from Laurance Rockefeller in the United States to accelerate specific research projects. This included a two-year investigation into claims of circle hoaxing in southern England. My conclusions were not popular.

I reported that of the circles studied in southern England during that two year period, 20% represented a genuine mystery while 80% were man-made. My television announcement of these results and the subsequent distortions of truth set off a firestorm of controversy. Some of the research I conducted with Rockefeller funds are part of the Rockefeller Initiative. This included UFO disclosure efforts within the Clinton White House.

In 2000, after two years of undercover research into the people believed making the circles in England between 1999 and 2000, the evidence again was totally compelling that approximately 80% were man-made. I looked at all the data from start to finish again and saw that there was one common denominator in all this and that was the highly mysterious events being witnessed by researchers and the public alike, and even by the people making them.

So the question then became: "Why are they being made and to whose plan?" A big jump from the original question and way

beyond what the media could work out for themselves, nor did they have the courage to head there. We are starting at the beginning, where any detective has to and will finish up at a verdict when all the evidence has been gathered and thought through.


One thing is for sure and should be stressed at this stage. There is no advantage for any of us to create myths or new religions as we experience the realization that emotions are impacted significantly by what we see in these fields and/or, what we would like to believe. Emotion is I believe part of a much larger study and perhaps even key in understanding what could be described as the biggest social experiment in our time and just when we needed the lesson.

I know from personal experience that no one likes their belief system challenged and they sure don't like facts that force it. Well known people in this research are in vast denial with major parts of the puzzle and so to complete the task of understanding it, is impossible. Even worse is that some know better but don't have the courage or honesty to come clean. I know that for a fact. A full eight years after I announced the findings of the Rockefeller financed study, that only about 20% could not be explained, many who are in the public eye, refute even one circle is made by people. "Extraordinary but let's continue in the next week or two," to move this forward without malice to those we don't agree with.

I have no axe to grind with these people, but feel compelled to open this debate again in the interest of making a clear case for my conclusion.

Crop circle reports have been accompanied by UFO sightings since the earliest records of the phenomenon. However many UFO researchers did not want evidence of this association in the public domain. Some did not want it because the emphasis on crop circles took the focus off their own UFO research. Others did not want the association because they believed that ultimately the crop circles would be proven man-made and they were afraid this would taint 'legitimate' UFO research. Still others were part of government disinformation.

Several times during the course of my research I was actually warned not to link UFO's with crop circles. I was warned by prominent members of the British UFO Research Association (BUFORA) not to mention the two together in media interviews. When I did not comply BUFORA sent letters to the MoD warning of concerns over my and Pat Delgado's claims regarding crop circles.



I have compiled some reports that the MoD investigated or were apprised of in the early years of my research. The following report is one Pope speaks to directly in his article.

The Ghost Plane

On the 22nd of October 1987 a very bizarre event occurred in the air over southern England. A Harrier TR5 vertical take-off jump jet disappeared during a test flight over the Salisbury plain military zone in Wiltshire. As the jet approached Boscombe Down airbase, radio contact went dead and the aircraft went missing. A full land, sea and air search was launched.

The Harrier jet was eventually spotted by an American military aircraft flying from South Wales. The aircraft pilot spotted the jet flying on a set course and moved in along side it sending a radio report of his finding. The canopy of the plane was shattered and there was no pilot flying the Harrier indicating the pilot had been ejected out of the plane through the canopy.

A Harrier fighter pilot "disappeared" over Wiltshire and the aircraft flew on for hundreds of miles with no-one at the controls.

A massive air-sea-land search was stepped up for the pilot, whose last contact was a routine radio message to air traffic controllers at the top secret Boscombe Down air base near Salisbury.

The Harrier, on a test flight from Dunsfold in Surrey, took off at


A Ministry of Defence spokesman in London said that the pilot suddenly lost radio contact.

The massive search for him concentrated on the flight-path taken by the


Harrier from its last con-tact point over Wiltshire. It was being intensified today and involved a Nimrod RAF reconnaissance aircraft and seven Royal Navy and RAF Sea King and Wessex helicopters

The media named the Harrier the Ghost Plane. The plane eventually ran out of fuel and crashed 300 miles out into the Atlantic Ocean. The plane had flown over three series of crop circles and the body of the pilot was later found very close to a set of circles. Although the presence of circles was not that unusual in that area at that time of year, a dead pilot was.

On November 2, I received a phone call from Squadron Leader Graham Davis which was followed by a phone call from Squadron Leader Pike, both from Prospect House division at the MoD. They were asking me to supply information about unusual effects ascribed to crop circles.






I shared associated electromagnetic anomalies and unusual aerial phenomena. They were investigating all possible explanations for the strange series of events including why the pilot was ejected from his craft through the canopy. An explanation was never found and the verdict was left opened.

Nick Pope states, "I had to deny that the 22 October 1987 crash of a Harrier aircraft was caused by energies associated with crop circles and that these energies had caused the spontaneous firing of the pilot's ejector seat leading to the man's death (the body was found in Wiltshire not far from where some crop circles had appeared in the summer)."

A SUDDEN blast of noise may hold the key to the mystery of flattened circles in cornfields.

It was recorded by a BBC TV crew at the centre of one of the circles, which some people say could be caused by UFOs.

There was no sign of a source for the sound, but the man they were interviewing said he felt an invisible force. Today viewers will have a chance of helping to solve the long-running puzzle when a tape of the sound and film of the drama are played on Daytime Live on BBC 1.

An incredible 270 giant circles, mainly in cornfields, were reported between May and September this year, against only 94 in 1988.

But the sound blast experienced by BBC pro-ducer David Morgenstern and his team is the first definite evidence of energy forces at work.

Technicians at Broadcasting House have spent weeks analysing the noise but still cannot identify it.

Interview

The blast happened during an interview with electronics engineer Pat Delgado, co-author of the bestseller Circular Evidence about the mystery.

He said yesterday: "It was so loud the sound engineer tore off his headphones and I felt myself being physically moved by the energy force.

"This could be the breakthrough we have been looking for.

"Something beyond our scientific knowledge is going on and we cannot rule out extra-terrestrial activity."

Producer Morgenstern said: "We picked up very powerful radio interference from the centre of the circle, but when we moved out it disappeared.

"BBC crews tend to be very cynical about this sort of thing but we were very taken aback.

"Now we want people to watch the film and ring us in with any information about crop circles they may have."

The team were filming in a cornfield near Silbury Hill, Wilts, site of one of the most ancient monuments in Europe.


It is odd to me that Nick Pope is in a position to make a pronouncement of what did not cause this accident when the official inquiry could not. I am certainly not suggesting the crop circles or forces involved with the construction of some of them had any thing to do with these events.

However I find Pope's denial interesting. Was he not aware that the investigation had included this possibility? Or was he trying to divert interest away from the reality that official investigators did in fact pursue this line of inquiry, as any thorough examination would.




Crop Circles in the USA

As we detailed in a previous chapter, the late Colonel Philip Corso, who was on President Eisenhower's National Security Council from 1953-1957, and the Chief of Pentagon's Foreign Technology during 1961, told me that he was shown reports of crop circles that were received at the White House. These reports were handed onto the NSA for study.



Colonel Corso details in his book, *The Day After Roswell*, how he managed extraterrestrial artifacts recovered from a crash at Roswell, New Mexico, in 1947. He says that he helped reverse engineer these artifacts which indirectly led to the development of particle beam devices, fiber optics, lasers, integrated circuit chips and Kevlar material. He further claims that a covert government group called Majestic 12 was organized under the leadership of the first Director of Central Intelligence, Adm. Roscoe H. Hillenkoetter. Among its tasks was to collect all information on extraterrestrial spacecraft.

He also spoke to me about the governments theory and discussed complex formations seen in the United States. Since my meeting with him (and after his death), I have had it confirmed by an NSA operative that highly complex designs were discovered in the USA before they evolved in England during 1990.

These sketches were later sent to me by the NSA operative along with details surrounding the 1969 and 1976 discoveries in Michigan, USA. According to my source UFOs were "regularly" seen at the site of pattern T0455. I was also told that USAF Col. Alex Nielson visited the site with Allen Hynek. They visited eye witnesses at the second site T0458 who reported strange creatures holding devices like those seen by witnesses at Silbury Hill in England, years later.

The Silbury Hill incident was in the same fields that the British Army deployed special units to a covert surveillance project during the period of Blackbird in 1990.

"I think this horrible mishmash of lies and deception is not all that it appears."

The Duke of Edinburgh said, "If it is a hoax it is elaborate in the extreme and I am inclined to believe it is due to some kind of invisible force....! Could this force have anything in common with the force exhibited by Uri Geller?" People with curiosity and intelligence feel stimulated by the unexplained and apply their minds to reach greater understanding. We should not be surprised that everyone, the public, the military, the government and the Royal Family would be caught up in the intrigue of the phenomenon.

What is remarkable is the need to deny it. Its important here to note that our future is dictated by human consciousness and that is an invisible multiplexed holographic force which is driven by what we think and how we react. Any input to the hologram, whether by governments, religions or the like, dictates a directional deviation - that is a huge responsibility for our time.

The lessons to learn from all this is that blind loyalty and trust in Government much like the financial institutions, big business and even many religions has not served us well. Our apathy in not challenging these institutions has allowed distortions of truth due to mind-sets and agendas resulting in wasted precious time,

wasted precious time, effort and the loss of opportunity to expand our knowledge. In many cases those entrusted with the job of protecting and serving the people are those who have failed the people.

Remember that it was not just the public who were deceived. Questions in the House of Parliament reveal that Prime Minister Thatcher was deceived as can be seen in Hansard. Deception and spin is now the expected government reaction to questions they don't want to answer so why should we wonder that public servants would lie to us as well as to our senior representative - The Prime Minster and head of state, the Queen. It does not get much more concerning than that.

You may be asking yourself now WHAT IS THE TRUTH AND WHAT DO THEY KNOW? Or more importantly why do they need to deny interest?

I think this horrible mish-mash of lies and deception is not all that it appears. Personally I like Nick Pope and don't think he is purposefully misleading but has simply not been given all the facts behind what he was asked to represent as MoD spokesperson. I might be wrong, but I suspect this approach was arrived at by their fear of what might be behind the circles and UFO reports.

What was revealed is their disorganization, lack of know-how and even pure disinterest in keeping the public informed.

The advancement of human consciousness comes out of evolving experience and modified existence and that means science and knowledge must take us forward on a foundation of respect and factual reporting - that is NOT what we have had here.

We have facts being distorted to reflect a mind-set thus subverting growth. We have to be able to imagine our future, embrace the truth and emotionally grow into it. But as you correctly surmise, my former bosses are never far away, Best wishes, Nick Pope"




Documented Evidence For Government Involvement In Crop Circle Investigations





Government Field Report



In 1985 Lt Col Section 401 then SO1 STANDARDS/NIGHT SAFETY HQ DAAC, was contacted by a local farmer asking what the AAC had been doing to his corn. Taking the Technical Accident Investigation Officer (AIFSO) with him he visited the area which was about 2 miles from Middle Wallop. It turned out to be a perfect set of circles in the corn.

Neither he nor the AIFSO could find any sensible explanation for the rings accept to state categorically that it was nothing to do with helicopters. Colsection 40 submitted a factual report to MOD, accompanied by good photographs, stating what they saw and their inability to explain it.

A local man, Mr Colin Andrews (author of Circles in the Corn) a member of a group who had been investigating the circles for some years, also turned up on the scene. Col Section 40 became intrigued and that year, 1985, passed the word round to UK based AAC units to let him know if they saw any circles and give him the Grid Ref. There were one or two responses and then interest waiwed.

Col Section 40 was subsequently approached by BBC TV Pebble Mill, who were making a film about the circles, to again be the helicopter agent and debate the helicopter theories. This he did, and laid on a demonstration with a helicopter in long grass to conclusively illustrate the facts. This was all filmed and shown on TV. Lt Col Section 40 continues to take an inactive interest in the circles and would be delighted to be given a satisfactory explanation for them.







First "Crop Circles" Report

This report has been prepared by Colin Andrews M.A.S.E.E., A.I.L.E.

Co-ordinator of CIRCLES PHENOMENON RESEARCH. (C.P.R.)

What are these circles?

The "circles" are areas of flattened vegetation most usually found in cornfields around harvest time. The first circle to arouse much interest was reported in July 1976 in a field at Headbourne Worthy near Winchester, similar to that in Plate 1. Within the circle the wheat stems had been flattened to the ground in a spiral wheel effect. The crop all round remained totally uneffected.

Since that time in 1976 further circles have been reported and the graph (Plate 2) shows that they are appearing in ever increasing numbers, till this year when it will be noted there were 96 "events" all, bar one in Leicestershire, were in Sussex, Hampshire, Wiltshire, Berkshire and Oxfordshire.

Some circles have been reported in other countries, but nothing by comparison with the awe-inspiring magnitude of the activity in Southern England.

The single circles were followed by ever increasingly complex formations. The first of these was a quintuple one, a large central circle surrounded by four smaller ones, each with a diameter of 13ft (See Plate 3). New forms are being discovered each year and Plates 4, 5, 6 & 7 show clearly the complexity of the patterns - especially Plate 4 showing the triangular group which appeared at Corhampton (Hants). This was one of two such identical impressions and both appeared during June 1988 within eight miles of each other. The plants in both took on an extra-ordinary pattern, they began to grow into a cartwheel (easily identifiable from the air) with 48 spokes and 7 concentric rings - the outer ring of each of the 3 circles was 10 meters across. Agronomists had never before seen this behaviour in plants.

All this expanding activity suggests that whatever is causing these "events" is evolving and at a very fast rate.

It would appear that there is a quite unique mystery.

Up till now C.P.R. has funded all the research from their own pockets. This includes the light aircraft for air surveillance needed to spot the circles and the thousands of miles of motoring visiting the sites or the owners of the fields where the circles have appeared, who very often are considerably disenchanted by having an area of wheat flattened, however if next year the upward trend in the frequency of "events" is maintained they will be unable to cope. During the last few days (early December) an approach has been made by the Japanese who are taking this phenomenon extremely seriously and are prepared to invest whatever it takes to get their hands on this "new energy" if that is what it is. C.P.R. do not want to let something that they have worked for and which is British to get 'stolen' by the Nipponese but for them to continue they must have Sponsorship. To do the task justice it needs 2 full time researchers and a list of their equipment with approximate cost is at Appendix A.

What is C.P.R.?

Circles Phenomenon Research is made up of a group of professional people encompassing several disciplines but mainly at the moment Scientists and Engineers who are trying to get to the bottom of the mystery.

For 5 years they have been investigating every circle or series of circles that get reported and have created a databank with all their findings. They have had a significant break through in recent months when a network of geomagnetic force was found in a consistent pattern on or leading to/from the circles. This energy field is, not surprisingly, absent from the circles made by kids for a hoax, nor is it considered possible for say University Students to change the molecule structure of standing wheat in geometric patterns on 94 occasions between May and September all over Central Southern England. Anyway, what would be the point?


Other theories that have been examined include:

Many of these can now be eliminated but much more work is required on others. C.P.R. group is tending now to think that it is possible that we are being given a demonstration of a source of energy beyond the experience of man's knowledge today and that were it possible to discover the means by which the energy is created and controlled we might have in our possession the capability to fulfill our energy needs without the environmentally devastating effects produced by the power stations we have used to date.



I am aware of the interest you have taken in the investigations being conducted by Colin Andrews and his Associates in an endeavour to solve the mystery of the Comfield Circles.

Dear Kr Ryder,

As co-ordinator of the Scientific Research Programme currently being conducted into the cause of mysterious ground markings appearing across southern England and in a number of other parts of the world. I feel it is my duty to inform you of a major escalation of this unexplained phenomenon.

During the last 21 days a total number of 63 circular areas of compressed vegetation have been discovered in the counties of Hampshire and Viltshire. As of this time, only 3 of these are located in Hampshire, the remainder are in 4 major pockets in the vicinity of Avebury in Wiltshire. Both myself, as co-ordinator of this research group and Dr Terrance Meaden, head of the Tornado and Storm Research Organisation, with whom we are working closely, both feel that very detailed analysis of the affected plants should be conducted as a matter of great urgency as the events are occuring in a whole variety of cereal crops and consequently will enter the food chain. Amongst the wast amount of data now gathered in Andover, several occurances have resulted in the affected plants growing into extraordinary patterns, this strongly suggests a molecular change has taken place. Until such time as conclusive evidence is found that there is not a form of molecular contamination within these plants the affected crops should most certainly not be harvested. Precise locations will be provided on request. I would urge you to take immediate steps to safeguard the public and ban the harvesting of the crop pending detailed analysis. Attempts are being made to raise the matter in the House in the very near future. While certain correlations do exist in the research data we are a long way off resolving the cause of these extraordinary and most complex formations. 


Overlapping swirl-pattern diagram.







They already knew that carrying a delicate, multimillion-dollar cargo of machinery along 75km (47 miles) of

Speaking to The Times in Kabul in July, officials involved in planning the operation said that British commanders preferred instead to wait until next spring's poppy harvest, a guaranteed point of low ebb in the Taleban's activities, to launch the convoy.

In spite of these misgivings, Nato came under pressure from Washington to secure visible progress in the Kajaki hydroelectric project to safeguard future funding lines before the US presidential elections.

Since 2004 almost \$28 million had been spent by the Louis Berger Group (LBG), the American company contracted by the US Government to fix and maintain the Kajaki plant's two existing turbines and install a third. Overall, the project — including future work such as the addition of a powerhouse and the reconstruction of transmission lines — had a total of \$100 million dollars earmarked from USAID, the American development agency.

But the Kajaki project ground to a halt two years ago when British troops deployed in the area and became embroiled in regular clashes with insurgents. The crucial third turbine sat in Kabul and, with no improvement in security, USAID funding lines were under threat.

LBG's schedule for completing the installation of the third turbine had been set originally for June 2007. As a result of the delays the completion date was reset to September 2008. LBG said that if any part of the critical machinery carried in the British convoy was damaged or destroyed it would take between nine and twelve months to reorder, delaying further installation work on the third turbine until at least 2010.

Better, therefore, they argued, that the British convoy attempted the route this summer, so that any damaged equipment could conceivably be replaced in keeping with the new time-line.

Questions were also raised about strategy. The overarching gambit behind the Kajaki project was to influence locals into supporting the Afghan Government with the enhanced electricity supply. However, insiders pointed out that much of the Kajaki Dam's existing power output was already controlled and taxed by the Taleban as it travelled though districts held by the insurgents. The installation of a third turbine was thus unlikely to undermine Taleban authority in the short term, and could actually boost it.

When The Times tried to publish a story reporting these concerns among US and other Nato officials, the article was blocked by a Ministry of Defence D notice, on the ground that it would endanger forthcoming operations.

As British troops, dust-covered and exhausted, return from Kajaki having completed the operation, critics of the British mission in Afghanistan should give them the credit they deserve for having successfully completed the most daring, ambitious and complicated operation in southern Afghanistan since they were deployed there.

Equally, however, those claiming that all is well that ends well should remember that the Government allowed its men to be risked in a questionable operation at an especially vulnerable moment, silenced the press in order to do so, and that the long-term implications of the Kajaki operation remain as yet unknown.



Military snapped crop circles

THE Ministry of Defence tried to stop military helicopter crews photographing crop circles for fear that this contradicted the official line that it had no interest in the phenomenon, secret files revealed. In 1991 the Centre for Crop Circle Studies wrote to the department highlighting cases where military aircraft had apparently hovered over fields where the elaborate patterns had appeared – and on at least one occasion taken pictures.

This concerned the MoD so much that it wrote to Army and Navy chiefs asking them to ensure this did not happen again.

But both services refused, saying they would "not be taken seriously" by air crews if they issued such an edict and suggesting the department was being "over-sensitive towards the UFO lobby".

The MoD request, dated August 1 1991, read: "The fact that photographs have been taken from Army Air Corps helicopters puts us in a difficult position, even if this was done during routine training flights.

"The MoD's position with regard to UFOs is that we do not devote time or resources to investigation of such reports unless an incident has any defence significance.

"For the AAC to involve themselves in this way erodes this position as the UFO lobby will see this as active investigation of UFO-related activity (as they view crop circles)."

A senior officer in the Army Air Corps wrote back the next day.

The letter read: "Frankly I am reluctant to start firing off edicts about what AAC pilots can and can't do when they spot crop circles beneath their helicopters - I am pretty sure that I wouldn't be taken seriously if I did."

The Navy's reply was similarly robust, asking: "Are we not being over-sensitive towards the UFO lobby here?"

It continued: "It seems odd that we should impose an artificial constraint on servicemen to avoid association with crop circles simply because of the antics of the lunatic fringe."

Nonetheless the MoD felt it was able to reassert its official position to crop circle enthusiasts.

On August 7 1991 the department wrote back to Ralph Noyes, honorary secretary of the Centre for Crop Circle Studies.

An unidentified Whitehall official insisted: "I should state at the outset that the Ministry of Defence has no interest in crop circles, and is conducting no research or investigation into this phenomenon...

"There can be no question of MoD resources being used to support investigation of the crop circle phenomenon."

Crop circle and UFO reports released

The Ministry of Defence launched an investigation into a flurry of UFO sightings across the West in the late Eighties and early Nineties, according to secret papers released yesterday.

Incidents included bizarre spacecraft making crop circles, mysterious burning lights seen for miles and triangular shapes flying over two West cities. But anyone hoping for Government acknowledgement of extra-terrestrial life visiting Britain in the release of the files under the National Archives' 15-year-old rule is going to be disappointed.

The MOD and official UFO investigators pour scorn on the sightings, dismissing them as misidentified pop festival light shows, American military jets refuelling and hot air balloons.

The period covered by the latest publications deals with the crop circle mania between 1987 and 1993, when the fields of Wiltshire were full of researchers, ufologist and worldwide media.

In the early days of the crop circle phenomenon, the MOD explained crop circles were a naturally occurring phenomenon, but when it became apparent in the late Eighties that they weren't, the military changed tack.

In 1989, at the height of crop circle mania, the secret papers reveal that when Mrs Thatcher expressed curiosity over the phenomenon and interest in the work of the early crop circle researchers, the semi-official Government UFO researchers wrote to her to warn her not to be taken in.



Media Coverage

The British UFO Research Association, which had close links with the MOD, told Mrs Thatcher: "We have been studying the circles since they first appeared in 1980 and can provide documented evidence that demonstrates just how much of what Andrews and Delgado (the two leading croppies at the time) are claiming is highly suspect.

"These circles appear throughout Britain, have done so for many years, and are no threat to anybody."

That line became official MoD policy on crop circles, but when multiple circles and formations appeared, the MoD was forced to change tack, and blamed people.

One farmer near Avebury complained of crop circles appearing in his fields, and blamed helicopters from nearby RAF Odiham. The circles were investigated, and one RAF chief wrote to MoD chiefs: "He believed that the damage may have been caused by hovering helicopters and asked us to take a look. "This was definitely not the case, and I personally suspect hippies with scythes!"

The MoD couldn't explain one report which will excite modern-day crop circle researchers. In July 1991, a driver and his wife pulled off the A350 south of Warminster and watched, spellbound, as a bright whirlwind created a crop circle in front of them.

The MoD report read: "Four whirlwinds, spiral from centre of circle - bright white.

"Swishing noise (distant). Moving around each other in a form of a circle and then disappeared."

The released papers also detail mass sightings by hundreds of people of the same mysterious phenomena often miles apart. On August 4, 1987, hundreds of people reported seeing strange triangular-shaped objects and lights travelling over Devon.

First sighted in Exeter and then Plymouth, the MoD later told witnesses the lights were probably from US military jets refuelling.

The papers also reveal how people from all over Britain, including the West Country, sent in sketches of UFOs they saw, and even the aliens who they claimed emerged from them.

GWR radio was one of the first of many media to visit Operation Blackbird. Their outside broadcast vehicle (seen with the mast tower above) was in position and ready to cover the moment that Colin Andrews and Pat Delgado entered the field to look at the new crop circle formation which appeared in front of the bank of special cameras. Looking through binoculars from the control vehicle (black structure) the report was that there was something in the center of the circle. This followed reports from observers at 4am that morning, that a triangular array of lights hovered over the field. As dawn broke, Colin and Pat entered the field. TV camera were kept out of the field as four military aircraft suddenly came in from the east and flew at low level directly over their heads. GWR radio were about to go live to air when the station received a D-Notice from the MoD to stop all transmissions.





Colin Andrews Biography

Colin Andrews is best known for his research into the crop circle subject since 1983. He provides the only continuity between the past research era and the present, along with his friend and colleague, Busty Taylor. 

Colin's twenty-five year investigation continues with growing urgency for openness and honesty in government and private research, respect for divergent opinions and co-operation between investigators in all areas.

Biography

Colin Andrews is an electrical engineer by profession and was a principle official in British Regional Government during the 1970's and 80's. He became involved in the crop circle mystery in 1983 when he saw an arrangement of five circles in a wheat field near Winchester, England. Intrigued by the engineering aspects, he began investigating the circles with Pat Delgado, a retired NASA engineer and Busty Taylor a light aircraft pilot. During his years of research he advised Prime Minister Margaret Thatcher's cabinet on the mystery, supervised the largest crop circle surveillance project in 1990 named 'Operation Blackbird', and amassed the largest data base in the world on the subject. 'Operation Blackbird' was an effort to film a genuine crop circle forming. It was sponsored by BBC and Nippon television and was authorized to take place on Ministry of Defense land and with British Army assistance.

In 1996 Colin was asked by Laurance Rockefeller to provide information for the Rockefeller Initiative. The Initiative provided the United States government with the 'best available evidence' regarding the UFO with the purpose of opening public dialogue. Colin continued to receive funding in 1999 from Laurance Rockefeller to conduct a two year investigation into crop circle hoaxing. He put together a team who studied the construction patterns of man-made crop circles that had been commissioned by various commercial and media interests. In addition, members of his team infiltrated several circle-making groups uncovering new information regarding the level of anomalous phenomena experienced by the hoaxers while making circles.

Using man-made circles as a base, Andrews studied the formations that appeared in England throughout 1999 and 2000. His research data brought him to the unpleasant conclusion that 80% of all the circles he studied showed "unassailable" signs of being man-made. The remaining 20% showed all the signs of being part of the genuine phenomenon he had encountered 20 years earlier. The publication of this data was largely rejected at the time. Today, the majority of honest, unbiased researchers have come to believe the truth of Colin's assessment.


